Subject: Monthly Contribution for Security Guards (Day & Night Shifts)

Dear Residents,

The CK Adiithya Layout Residents Association (CKALRA) wishes to inform all residents that a proposal is being initiated to provide independent security services within the layout.

This initiative is being offered solely by the Association to its members on a voluntary, contributory basis and is NOT connected to layout maintenance, layout handover, or any responsibilities of the builder.

# Clarification Regarding Layout Handover & Authority

The builder is required to complete the layout handover to Surajakanahalli Panchayat/GBA, as per standard statutory procedure.

The builder must obtain the NOC from the Panchayat/GBA before the layout can be formally considered under Panchayat administration.

Once the handover is completed:

- The Panchayat or the Greater Bengaluru Authority (GBA) will take future decisions regarding layout infrastructure, maintenance, and responsibilities.
- Directions for long-term layout management will be issued only by the Panchayat/GBA, not by the Association.

Until such formal handover and directions are received, CKALRA is functioning independently as a voluntary resident body to provide essential services to members who choose to participate.

## Proposed Security Arrangement (Voluntary & Member-Funded)

To improve safety temporarily, the Association proposes the appointment of:

- 1 Security Guard Day Shift
- 1 Security Guard Night Shift

These guards will be hired with proper compliance—including PF, ESI, documentation, and fair wages—ensuring accountability and legal protection.
